LIMITED WARRANTY

BENZ Live Tool

Except as specified below, products sold hereunder shall be free from defects in materials and workmanship and shall conform to Benz Tooling - a Business Unit of SCHENCK USA CORP. 's published specifications or other specifications accepted in writing by Benz Tooling - a Business Unit of SCHENCK USA CORP. for a period of two (2) years or 4,000 hours, whichever comes first, from the date of invoice of the product.

Specialty Live Tools have a one (1) year or 2,000 hours, whichever comes first, warranty.

BENZ LinA Broach

Except as specified below, products sold hereunder shall be free from defects in materials and workmanship and shall conform to Benz Tooling - a Business Unit of SCHENCK USA CORP. 's published specifications or other specifications accepted in writing by Benz Tooling - a Business Unit of SCHENCK USA CORP. for a period of one (1) year or 2,000 hours (whichever comes first) from the date of invoice of the product or the tool is under the maximum number of hours of operation or number of stokes as specified in the LinA operation manual under section 7.3 Maintenance.

BENZ Right Angle Head and Speeders

Except as specified below, products sold hereunder shall be free from defects in materials and workmanship and shall conform to Benz Tooling - a Business Unit of SCHENCK USA CORP. 's published specifications or other specifications accepted in writing by Benz Tooling - a Business Unit of SCHENCK USA CORP. for a period of one (1) year or 2,000 hours, whichever comes first, from the date of shipment of the products. The foregoing warranty does not apply to any products which have been subject to misuse, neglect, accident, or modification. Benz Tooling - a Business Unit of SCHENCK USA CORP. shall make the final determination as to whether its products are defective.

Specialty Tools

Specialty tools may have a shorter warranty. Specialty tools produced by BENZ can be described as tools with extremely high rpm's where heat buildup is an issue or tools used in a damaging environment such as graphite, quartz, or ceramic manufacturing. The issues with these applications are the bearings and seals have a short or predetermined life expectancy due to the application or work environment. Tools used with internal coolant cannot be run dry and require the use of a 50-micron filtration to protect the seals. Tools with internal coolant seal contamination are not covered under warranty. Every tool sold is packaged with a drawing outlining the maximum and limited duty (ED) rpm. This should be always adhered to. Heat damage is not covered under warranty.

Applies To All Tools

The foregoing warranty does not apply to any products which have been subject to misuse, neglect, accident, or modification. Benz Tooling - a Business Unit of SCHENCK USA CORP. shall make the final determination as to whether its products are defective. Benz Tooling - a Business Unit of SCHENCK USA CORP. 's sole obligation for products failing to comply with this warranty shall be, at its option, to either repair, replace or issue credit for the nonconforming product where within fourteen (14) days of the expiration of the warranty period, (i) Benz Tooling - a Business Unit of SCHENCK USA CORP. has received written notice of any nonconformity; (ii) after Benz Tooling - a Business Unit of SCHENCK USA CORP.'s written authorization, Buyer has returned the nonconforming product to Benz Tooling - a Business Unit of SCHENCK USA CORP. has determined that the product is nonconforming and that such nonconformity is not the result of improper installation, repair, or other misuse.

LIMITED LIABILITY

Neither Benz Tooling - a Business Unit of SCHENCK USA CORP. nor Buyer shall be liable for incidental or consequential damages, including but not limited to, the cost of labor, requalification, rework charges, delay, lost profits, or loss of goodwill arising out of the sale, installation or use of any Benz Tooling - a Business Unit of SCHENCK USA CORP. product. If Benz Tooling - a Business Unit of SCHENCK USA CORP. has any liability for breach of contract, breach of any implied condition, warranty or representation, the aggregate liability of Benz Tooling - a Business Unit of SCHENCK USA CORP. to Buyer shall be limited in respect of any occurrence or series of occurrences to the contractual value of the products or services that are the subject of the contract.
